Application for admission to **INFORMATION SYSTEMS AUDIT COURSE ASSESSMENT TEST** is required to be made in the prescribed form. The application forms are priced at Rs. 25/- per application form. The candidates requiring forms by post may please send their requests to the Senior Joint Secretary (Exams), The Institute of Chartered Accountants of India, ICAI Bhawan, Indraprastha Marg, New Delhi – 110002, along with a remittance of Rs. 25/- per form by Demand Draft/ Indian Postal Order, drawn in favour of “ The Secretary, The Institute of Chartered Accountants of India”, payable at New Delhi and a self-addressed envelope in size 27.5 cms x 12.5 cms. The forms will also be available against cash payment for personal collection at the offices of the Institute at New Delhi and its Regional and Branch Offices from **13th May 2008**. Alternatively, the format of application form can be downloaded from the website of the Institute viz. **www.icaai.org** and the cost of the application form of Rs. 25/- can be added to the Assessment Test fee of Rs. 1000/- and the Demand Draft for Rs. 1025/- has to be sent. **The above Test is open only to eligible Members of the Institute who are already registered with the Institute for the said course.**

The last date for receipt of application forms is 3rd June 2008. The application together with the prescribed fee should be sent by Speed Post/Registered Post to the Senior Joint Secretary (Exams.), The Institute of Chartered Accountants of India, ICAI Bhawan, Indraprastha Marg, New Delhi - 110002. Applications **should not be** submitted either in Regional Offices or in Branch Offices and should be sent to the Head Office at New Delhi only. The candidates are advised not to send their applications through courier. The applications received after **3rd June 2008**

will not be entertained under any circumstances.
